TEACHING AND ADVISING

Teaching: University of Maryland, College Park

I have developed new literature and cultural studies courses at the graduate and undergraduate levels for the departmental curriculum to address both Transatlantic Literature and Cultures and the field of Colonial Latin America. I diversified the curriculum by introducing new courses on the Cuban revolution, Cuban literature, and Cuban Cinematic Culture for both the Latin American Studies Center and the Department of Spanish and Portuguese. I have designed also courses on Latin American Popular Culture in which I mix visual (Telenovelas) and literary materials, traditional readings and online discussions. More recently, I have re-designed courses that have become the gateway for students to move from language learning to literary and cultural studies and undertaken the coordination of multiple sections (Span 303, Span 361). For the Office of International Programs, I have designed several Study Abroad programs/courses for the winter term in Cuba (2002-03), Seville-Spain (2005-present) and Quito/Cuenca-Ecuador (2009-present), for the summer in Salamanca/Barcelona-Spain (2002-present), Colombia (2017), and also for the spring semester in Seville-Spain (2012-present). I have taught and co-taught in both English and Spanish and within different teaching formats, from the small seminar to the large lecture hall, across departments and for the University Honors Program. I receive excellent teaching evaluations on average.
